#### **SESSION EVALUATION SWEEPSTAKES RULES**

**No Purchase Necessary. A Purchase Or Payment Will Not Increase Your Chances Of Winning. Winners Need Not Be Present to Win. Prize Winners Will Be Chosen in Random Drawings.**

#### **1. Eligibility**

The Session Evaluation Sweepstakes (“Sweepstakes”) is open only to legal residents of the fifty (50) United States and the District of Columbia who have reached the age of majority in their state of residence at the time of entry and who are attendees at **IDF13**. Employees of Sponsor and its parent companies, affiliates, subsidiaries, distributors, advertising and promotion agencies, other vendors or independent contractors providing services to Sponsor in connection with **IDF13** and/or the administration of this Sweepstakes, and members of the immediate family (defined as spouse, parent, sibling, child and respective spouses regardless of where they reside) and/or those living in the same household of such employees are NOT ELIGIBLE to enter.

#### **2. How to Enter**

There will be three Entry Periods, each with its own drawing and prize. Entrants must have “registered” his/her attendance at the session for which he/she is submitting an Online Session Evaluation by scanning his/her badge using the IDF scanner outside the session room. For Entry Period 1: All entries for sessions held between 11:00 AM PDT and 6:00 PM PDT on Tuesday, September 10 must be received by 10:00 AM PDT, Wednesday, Sept 11. For Entry Period 2: All entries for sessions held between 11:00 AM PDT and 6:00 PM PDT on Wednesday, September 11 must be received by 10:00



AM PDT, Thursday, Sept 12. For Entry Period 3: All entries for sessions held between 10:45 AM PDT and 3:15 PM PDT on Thursday, September 12 must be received by 10:00 AM PDT, Friday, September 13. Limit one entry per person/per session attended. Entrants may enter and be eligible for prizes in more than one Entry Period. Entries for each drawing must be received prior to the dates and times indicated above. To enter without completing the Online Session Evaluation, hand print your name, address, telephone number, email address and Session ID for each session you attended on a separate 3x5 card and bring the card(s) to the IDF Speaker Lounge located in Room 2012 of Moscone Center West by 10:00 AM on the day following the session(s) you attended. Written entries must be received by 10:00 AM the day following the attended session(s) to be eligible to win a prize.

### **3. Prize Drawings**

Winners will be selected in random drawings from among all eligible entries received by (1) 10:00 AM PDT Wednesday, September 11 (for Entry Period 1), (2) 10:00 AM PDT Thursday, September 12 (for Entry Period 2), and (3) 10:00 AM PDT Friday, September 13 (for Entry Period 3). Drawings will be held by representatives of Sponsor, whose decisions on all matters relating to this Sweepstakes are final and binding. Winners will be notified by email. Winners need not be present to win.

Failure to comply with this deadline may result in forfeiture of the prize and selection of an alternate winner.
