## Summary

Authors should state their names as Forename Surname. The principal author should be emboldened and in the primary place and should include an email address as above. Leave a blank line between authors and affiliations. Affiliations are formatted as a numbered list (see document styles) with superscript numbers. Leave a blank line after the affiliations list and state the e-mail of the principal author. Also leave a blank line between the end of the summary and the beginning of the main text. *For your convenience, just replace the contents of this document with your own.* The summary should look like this paragraph. It should contain about 100 to 150 words.

## 1 Detail

Your abstract should ideally fit into an A4 page using the layout of this document. Base font for all text is times new roman at 10pt, 12pt line spacing (not smaller). To stress a word, *please use italic letters.* For itemized and enumerated lists, please refer to the document styles provided and to the examples below.

The format of the list of publications is shown below. When citing in text, just use the number of the reference in brackets like this [1]. The list may be sorted in order appearance in the paper or also chronologically.

Illustrations must appear within the designated margins. They may span the two columns. Caption and number every illustration (use the document style "caption"). The proceedings will be printed in greyscale. If you use any colours in illustrations please check the contrast. Otherwise this might result in poor reproduction at your own risk. Illustrations should be of a resolution of at least 600 dpi.

You may place figures and tables within a single table cell (figure 1, table 1) to keep figure and caption together. Figures and tables may span both columns. However, never exceed the page margins.

Please save your paper as Microsoft Office 2003 Document (Office 2007 user please save file as "Word-97-2003-Document") and send it by E-Mail to intel.research.conference@intel.com. In order to ver-

ify your intended format and page layout it is helpful that you additionally send a PDF version of your paper.
