If you are a consumer, this Warranty does not apply to you. For warranty support please contact your original place of purchase.

Subject to the exclusions and limitations contained herein, Intel warrants to Intel's Distribution customers that the Product (defined herein as the Intel® NUC Laptop) contained in this box and all of its various components (excluding battery), in its original sealed packaging ("Original Purchaser") as follows: if the Product is properly used, it will be free from defects in material and workmanship and will substantially conform to Intel's publicly available specifications for a period of two (2) years beginning on the date the Product was purchased in its original sealed packaging. The battery is covered by a one (1) year warranty subject to the exclusions and limitations contained herein.

SOFTWARE OF ANY KIND DELIVERED WITH OR AS PART OF THE PRODUCT IS EXPRESSLY PROVIDED "AS IS" UNLESS SPECIFICALLY PROVIDED FOR OTHERWISE IN ANY SOFTWARE LICENSE ACCOMPANYING THE SOFTWARE.

If the Product which is the subject of this Limited Warranty fails during the warranty period for reasons covered by this Limited Warranty, Intel, at its option, will:

- **REPAIR** the Product by means of hardware and/or software; OR
- **REPLACE** the Product with another product, OR, if Intel is unable to repair or replace the Product,
- **REFUND** the then-current value of the Product at the time a claim for warranty service is made to Intel under this Limited Warranty.

Intel may elect to repair or replace the Product with either a new or reconditioned Product or components, as Intel deems appropriate. The repaired or replaced Product will be shipped to you at the expense of Intel within a reasonable period of time after receipt of the returned Product by Intel Customer Support ("ICS"). The returned Product shall become Intel's property on receipt by ICS. ICS may recover the originally configured operating system bundled with the Product. The replacement Product is warranted under the terms of this Limited Warranty and is subject to the same Warranty Limitations and Exclusions for ninety (90) days, or the remainder of the original warranty period, whichever is longer.

THIS LIMITED WARRANTY, AND ANY IMPLIED WARRANTIES THAT MAY EXIST UNDER APPLICABLE STATE, NATIONAL, PROVINCIAL OR LOCAL LAW, APPLY ONLY TO YOU AS THE ORIGINAL PURCHASER OF THE PRODUCT.

EXTENT OF LIMITED WARRANTY

Intel does not warrant that the Product, whether purchased stand-alone or integrated with other products, including without limitation semiconductor components, will be free from design defects or errors known as “errata”. Current characterized errata can be found at this link:

This Limited Warranty does NOT cover:

- Normal wear and tear due to use of the Product.
- Accessories, parts or software added to the Product after the system is shipped from Intel;
- Any costs associated with the replacement or repair of the Product, including labor, installation or other costs incurred by you, and in particular, any costs relating to the removal or replacement of any Product soldered or otherwise permanently affixed to any printed circuit board or integrated with other products;
- Errors resulting from incorporation or combination of the Product into or with any other product, service, or system;
- Any malfunctions or other errors in the Product caused by any third-party virus, infection, worm or similar malicious code;
- That the Product will protect against all possible security threats, including intentional misconduct by third parties;
- Damage to the Product due to (1) external causes, including accident, problems with electrical power, abnormal conditions (such as mechanical or environmental) (2) usage not in accordance with Product instructions, (3) misuse, neglect, alteration, repair, (4) improper installation or improper testing; (5) operation outside environmental specifications, (6) Non-Intel supplied software or hardware;

- Where the original Product identification markings (trademark or serial number) have been removed, altered or obliterated from the Product.

Battery (One (1) year Limited Warranty)

- The battery contained in this Product is covered by this warranty for the period of one (1) year. As with all batteries, the maximum capacity of the battery included in the Product will decrease with time or use. The battery warranty does not cover changes in battery capacity. Your battery is only warranted from defects in materials or workmanship resulting in failure. Battery life is not warranted and will vary depending on Product configuration and usage including, but not limited to Product model, applications running, power management settings, and Product features.

Display Pixel Warranty Coverage

Subject to the exclusions and limitations contained herein, defective subpixels on the LCD screen of the Product are covered by this warranty only if they are permanent, visible to the naked eye at a normal viewing distance, and exceed the following criteria:

Bright pixels	More than 2
Bright adjacent pixels	More than 0
Dark pixels	More than 5
Dark adjacent pixels	More than 0
Total combined bright and dark pixels	More than 5
Space between bright and dark pixels	Two or more bright and dark pixels less than 15mm apart
Space between dark pixels	Two or more dark pixels less than 5mm apart

HOW TO OBTAIN WARRANTY SERVICE

To obtain warranty service for the Product, contact your original place of purchase in accordance with its instructions.

If directed by your original place of purchase, you must contact the ICS center in your region within the warranty period during normal business hours (local time), excluding holidays and return the Product and all of its various components to the designated ICS center. The Product must be returned intact, as originally purchased. Please be prepared to provide: (1) your name, mailing address, email address, telephone number (2) proof of purchase; (3) model name and Product identification number found on the Product; and (4) an explanation of the problem. ICS may need additional information from you depending on the nature of the problem.

Upon ICS's verification that the Product is eligible for warranty service, you will be issued a Return Material Authorization ("RMA") number and provided with instructions for returning the Product to the designated ICS center. When you return the Product to the ICS center, you must include the RMA number on the outside of the package. Intel will not accept any returned Product without an RMA number, or that has an invalid RMA number on the package. You must deliver the returned Product to the designated ICS center in the original or equivalent packaging, with shipping charges pre-paid (except as noted below). You assume the risk of damage or loss during shipment.

Shipping/Returns

Freight charges and/or handling fees may apply if the Product for which you are requesting warranty services was not sold via authorized distribution in your country/region, or if upon Intel's inspection of the Product, it was determined that the Product is excluded from warranty under the Extent of Limited Warranty terms above.
